Contract Rider 2023

The following terms and conditions will form part of your contract agreement with Reggie England represented by _____. Please read completely and return signed copy.

1. Billing: Artist to be billed as: Reggie England: A Tribute To Elton John
2. Sound, video and lighting system: (APPLICABLE IF VENUE TO PROVIDE) Purchaser will provide artist with a professional sound system, 4 monitors, 1 sound engineer, professional lighting system and adequate staging. A full sound check will be arranged for Artist before Showtime. Artist may provide their own sound engineer in addition to those provided by the purchaser at Artist's discretion & expense, to monitor and work in conjunction with purchasers' sound personnel. IMPORTANT: The mixer must have a minimum of 4 monitor mixes. The artist will provide their own in-ear system with XLR inputs for Reggie and the drummer. If videos are to be used, the venue will provide a projector and screen with a minimum of 5000 lumens. An HDMI cable needs to terminate near the piano. If an adequate projector and screen is not available the artist can provide one with transportation costs.
3. Publicity and promotion: Purchaser will provide quality publicity and promotion for the concert/show through social and print media. Promotion material can be obtained from (artist contact and email) Artist web site (website) will provide background information and photos.
4. Backline: Backline will be provided by Artist for drive-in shows. Venue to provide the following for fly-in dates:
 - 1) Baby Grand piano: Piano must be in good playable condition, recently tuned, and at standard pitch (A440). A digital Grand Piano is also acceptable with artist pre-authorization.
 - 2) Drums: A 5 piece (three toms, floor tom, kick drum) of professional quality with 5 cymbal boom stands and hihat stand. Artist will provide snare and kick pedals. A pro-level electronic kit is acceptable with artist pre-authorization.
 - 3) Guitar amplifier: Fender Deluxe or Vox AC15 (if applicable)
 - 4) Bass Amplifier: Powered head minimum 200 watts with 4-10 cabinet (if applicable)

5. Hotel accommodation: One double room per band member within 10 miles of the venue
6. Hospitality: One hot meal per band member and crew member or a \$40 credit per member at a nearby restaurant. Bottled waters on stage at all times.
7. Merch-Concessions: Artist retains the right to sell artists merchandise (T-Shirts, CD's, etc.) at the performance at no cost to the Artist.
8. Dressing room: Purchaser will provide artist with a private dressing room or equivalent.
9. Transportation: Purchaser to provide ground transportation on fly-in dates as agreed.
10. Guests: Artist to be allowed up to eight guests if event charges admission.
11. Parking: If Artist drives to venue, Purchaser will provide safe, adequate parking for artists.
12. Load-in/out: 2 HELPERS WILL BE PROVIDED BY PURCHASER AND WILL LOAD IN THE BAND GEAR FROM THE VEHICLE TO THE STAGE AND LOAD OUT FROM THE STAGE TO THE VEHICLE. THE BAND WILL CALL AHEAD PRIOR TO ARRIVAL TO CONFIRM THESE ARRANGEMENTS. Please provide artist with contact name & info prior to the day of show.
13. Advance: Artist representative will telephone Purchaser in advance at least one week before performance to verify all aspects of this rider and to confirm details of the performance agreement.
